Items for the Board's Information and Review

Governing Board Members' Update

Eastland-Fairfield Career & Technical Schools

Mrs. Spencer provided an update regarding the recent EFCTS Board meeting that included outstanding student presentations in the Math and Nursing programs.

Delaware Area Career Center

Mr. Bischoff updated Board members regarding DACC's construction project and the meetings underway between the architects and various stakeholder groups to obtain input.

Treasurer's Update

Mr. Hutchinson reported that the ESCCO is wrapping up the last week of benefit online open enrollment for staff. Mr. Hutchinson also informed Board members that the annual audit underway is in its last couple of weeks before completion.

Ohio Healthcare Consortium Update

Mr. Hutchinson reported that the Consortium Board met recently to review an appeal and informed Board members that the Consortium is in good shape in terms of claims at this time.

Superintendent's Update

Dr. Goodney provided the Board members with an update on space planning currently underway for the Central Office. The plan includes a reconfiguration and upgrade of breakroom, public spaces and the lobby to be more welcoming for visitors; technology upgrades in the conference rooms; program integration of the Human Resources and Fiscal Services staff for greater operation efficiency; storage and itinerant staff space.

Dr. Goodney distributed a summary prepared by Navigator Management Partners regarding the selection of an ERP (Enterprise Resource Planning) software package. Following review of the report that included feature comparison and summary of costs between MS K-12 and Sungard, a recommendation to purchase the software from Sungard was presented to Board members. Board members directed Dr. Goodney and Mr. Hutchinson to proceed with the negotiation of a contract with Sungard.

Dr. Goodney distributed a job description to recommend the creation of a new administration position – Director of the College and Career Success Network with a proposed starting date of August 1, 2016. Funding sources for the positon would include grants and projected professional development revenue. This administrator would report directly to the Superintendent and work with client school districts, career centers, business/industry, and community partners in the area of career opportunities for students and dual enrollment program development.

Dr. Goodney provided an update regarding the rules the Ohio Department of Education is preparing on funding changes for high performing educational service centers. ODE has asked Dr. Goodney to assist with the writing of the rules for review by the State Board of Education. OESCA is also currently working with the State Legislature on legislation to fix this flawed funding provision in law to eliminate performance funding.
